

## **User Agreement**

This user agreement (hereinafter – “Agreement”) is a public offer and defines the terms for use of materials and services presented on the Internet website at [www.openteleport.com](http://www.openteleport.com) (hereinafter – “Website”), administered by the Intersputnik International Organization of Space Communication (hereinafter – “Website Administration”), by the users of the Website (hereinafter – “User”) or the Website Administration.

### **1. General Terms and Conditions**

1.1. The Website was created in order to provide Users with the opportunity to present materials on the Website, get acquainted with materials presented on the Website by other Users or the Website Administration, interact with other Users, as well as to use the Website’s services.

1.2. ### **2. User Responsibilities**

2.1. 2.4.
